Welcome to the 2018-2019 school year. As the excitement of the new school year builds our focus continues to be placed on a number of facility improvements and upgrades taking place throughout the summer months. The primary work taking place is completion of renovation and construction at Palmyra Junior/Senior High School. Count-



less hours of managing these projects are necessary in order to make all of this possible. We are grateful for our opportunity to work with Cheever Construction, and if you see a Board of Education member, an administrator, or a member of our maintenance staff, please take time to thank them for their efforts to bring the project closer to completion.

In addition to preparing buildings for the upcoming school year the Board and staff have been busy completing or initiating a number of projects. Our staff have had the opportunity to engage in professional development sessions including attending the Google summit and work in a variety of curricular content areas that will provide exciting and innovative instructional upgrades for our students e.g. computer coding K-12 and a 9-12 math readiness project. We appreciate the work of our staff in attending training for Canvas, a student management platform we will be launching this school term in place of e-BackPack. Additionally, I am extremely proud of our summer school staff who spent many hours working to provide instruction to our largest ever group of students during the three week session in June. Mrs. Walter and our summer school staff at Bennet Elementary are to be commended for designing an exceptional program for


I would like to take time to introduce our new instructional staff for 2018-2019 school year. New staff members include Mr. Heath Johnson Secondary Principal, Caitlin Peterson and Rachel Carraher Grade 2, Casandra Hohensee Special Education, Zachary Wemhoff K-6 Physical Education, Kristine Lamb Early Childhood and Andrew Weils 7-12 Special Education. We will also be welcoming Dan Desmond as the Library supervisor at Palmyra High School. Please take some time to welcome our new staff to the District OR-1 family.

The high school remains committed to offering dual credit courses in our partnerships with Northeast Community College, Southeast Community College and Peru State College. Courses include but are not limited to: Composition 150, academy courses in the areas of Health Science, Business and Informational Technology, introductory education courses, and Algebra. It is unfortunate that we will be losing some instructors due to changes impacting the certification process for dual credit instructors in a negative manner. The current scenario reguires teachers to obtain additional credit hours in order to maintain their dual credit teaching status. We are fortunate that our staff has gone the extra mile to do that for the benefit of our students allowing us to continue offering dual credit algebra, thanks Mr. Maas for your efforts in obtaining this certification! As we prepare students to enter the SEN-CAP academies available in computer science I would like to thank Mrs. Hanger and Mr. Conn for their efforts in obtaining valuable coursework in computer coding allowing our students to receive instruction in both the elementary and secondary buildings. Also a special thanks to Mr. Jensen for his efforts in developing coursework to prepare our students for post-secondary math readiness. This pilot project involves District OR-1, Lincoln Public Schools and Beatrice Public Schools. We are pleased to be selected for this work.

The District remains focused on technology as we begin our third school year with the chrome book platform. They offer excellent functionality, price and ease of use in a now 4-12 setting. We are continuing to augment their use and will be introducing them to grade 4 students this fall. I would like to thank our staff who attended the Google Summit this July in a continued effort to provide the latest information and skills to our students. The conference was attended by Casandra Hohensee, Burke Brown, Rebecca Cunningham, Lisa Dowding, Gina Christensen, Carrie Wusk and Cassidy Buescher.

During the July BOE meeting the District OR-1 Board of Education reviewed the policy related to bullying. In that effort we continue to place a high level of importance on K-12 character education as the backbone of our effort to instruct staff and students how to recognize, respond and report bullying in order to reduce the negative impact it can have on our students and building culture.

The Department of Education has certified state aid for schools for FY 2018 (based on needs/resources). The chart below reflects state aid as certified in the amount of \$966,924 reflecting a reduction of \$302,716 due to valuation growth in FY 2017.



These changes in the aid formula also serve to move the district budget authority calculation from budget based to needs based for the foreseeable future. Budget authority for FY 2018 has been certified at \$7,273,819.

As I begin my 33rd year in education I would like to wish everyone the best in 2018-2019. Continue to take advantage of the many opportunities available at District OR-1, be productive and positive in your relationships and studies. Working together we will continue to move the district forward, GO PANTHERS!



As we start the school year Education Corner offers the following tips for success:

1. Don't attempt to cram all your studying into one session.

Ever find yourself up late at night expending more energy trying to keep your eyelids

open than you are studying?

2. Plan when you're going to study.

Successful students schedule specific times throughout the week when they are going to study -- and then they stick with their schedule.

3. Study at the same time.

Not only is it important that you plan when you're going to study, it's important you create a consistent, daily study routine. When you study at the same time each day and each week, you're studying will become a regular part of your life.

4. Each study time should have a specific goal.

Simply studying without direction is not effective. You need to know exactly what you need to accomplish during each study session.

5. Never procrastinate your planned study session.

It's very easy, and common, to put off your study session because of lack of interest in the subject, because you have other things you need to get done, or just because the assignment is hard. Successful students DO NOT procrastinate studying.

6. Start with the most difficult subject first.

As your most difficult assignment or subject will require the most effort and mental energy, you should start with it first. Once you've completed the most difficult work, it will be much easier to complete the rest of your work.

7. Always review your notes before starting an assignment.

Obviously, before you can review your notes you must first have notes to review. Always make sure to take good notes in class. Before you start each study session, and before you start a particular assignment, review your notes thoroughly to make sure you know how to complete the assignment correctly.

8. Make sure you're not distracted while you're studying.

Everyone gets distracted by something. Maybe it's the TV. Or maybe it's your family. Or maybe it's just too quite. Some people actually study better with a little background noise.

9. Use study groups effectively.

Ever heard the phrase "two heads are better than one?" Well this can be especially true when it comes to studying. Working in groups enables you to (1) get help from others when you're struggling to understand a concept, (2) complete assignments more quickly, and (3) teach others, whereby helping both the other students and yourself to internalize the subject matter.

10. Review your notes, schoolwork and other class materials over the weekend.

Successful students review what they've learned during the week over the weekend. This way they're well prepared to continue learning new concepts that build upon previous coursework and knowledge acquired the previous week.



Computer Science at Bennet Elementary!

We live in a world surrounded by technology. And we know that whatever field our students choose to go into as adults, their ability to succeed will increasingly hinge on understanding how technology works. But only a tiny fraction of schools are teaching computer science; fewer students are studying it now than a decade ago. Here are a few facts from Code.org:

- *Computing jobs are growing 3 times faster than the number of computer science graduates.
- * More than 50 percent of all math and science jobs are for computer scientists.
- * Computer science jobs are the highest-paying jobs for new graduates.
- * Computational thinking is important across all subjects.
- * Nebraska currently has 2,612 open computing jobs (3.2 times the average demand rate in Nebraska).
- * The average salary for a computing occupation in NE is \$76,542, which is significantly higher than the average salary in the state (\$44,170).
- * Nebraska had only 438 computer science graduates in 2015; only 15% were female.

We know not every student will have a career in Computer Science, but technology touches every field of study in some way. We want our students to have a background knowledge of programming and as much technological knowledge as they can. Bennet Elementary has adapted a Computer Science curriculum from Code.org. Their Computer Science Fundamentals courses for Elementary students has between 14 & 28 lessons per grade that will be implemented in 5th and 6th over the course of a year. Students create computer programs that will help them learn to collaborate with others, develop problem-solving skills, and persist through difficult tasks. They will study programming concepts, computational thinking, digital citizenship, and develop interactive games or stories they can share. We will still be typing and researching in the computer room, but this will be an added bonus to our learning. For more information please go to www.code.org

To Parents of School Bus Route Children: ...Cathy Fick

We have been busy working on bus routes for this year. Your bus driver will contact you approximately 1 week before school starts with your pick -up time. If you are new to the district and requesting bus service, please contact Cathy Fick right away, so that your name can be added to the routes.

These routes and times may not be permanent until we get everyone needing bus service registered. Times will vary the first week of school, depending on who is riding. Please be patient.

After the first week, times should be the same. The bus drivers can only wait one minute for students to get on the bus, so please have your student ready and waiting at their scheduled time. This will ensure that the bus will not be late to their next pickup or be late to school.

We ask that if your child will not be riding the bus at any time to please call your bus driver, or you may also call Cathy Fick 402-780-5636 or 402-540-2879. If you call my cell, please leave a message as it doesn't always ring in certain areas, or you can send me a text, and I will let your bus driver know. Please try to call the night before if possible. If not, please call at least 15 minutes before your scheduled pick up time. Even when you call the school, please call the driver as well. Phones are answered at school from approximately 8:00 a.m. to 4:00 p.m.

Please note that when school begins at 10:00 a.m. due to inclement weather, your pickup time will be approximately 1 hour and 45 minutes later than normal, i.e. an 8:00 a.m. pickup time will change to 9:45. Cathy will be providing those adjusted times as we finalize schedules.

If you have alternating drivers for your route, we request that you always contact Cathy, as they have alternating schedules and do not drive every day. This way I can get the message to the driver assigned that day.

We ask that you send a note with your child for any alternate plans for the bus e.g. if they are not riding home, if they are going home with another student, or if they are having a friend go home with them. If they don't have a note, the change will not be allowed. We have too many students to

manage alternate plans safely and confirm

that parents are aware of where children are being dropped off. Parents may call Cathy or their school office prior to 3:00 p.m. to make a change in afternoon plans. No calls will be accepted after that as buses may be in route and calls cannot be taken.

There is to be no food or drinks on the bus except for plastic bottled water. No suckers, sunflower seeds or gum as they create a mess that is difficult to clean. No skateboards, no spray deodorant or perfume. No calls on their cell phones, unless it is from their parents, as it distracts the bus driver and becomes a safety issue. If they need to call their parents, they need to let the bus driver know.

Drop off times after school can vary, depending on who is riding the bus that afternoon so we ask that you are flexible after school.

If you have any questions, problems, or if your child has a health issue that warrants your driver's attention, please call Cathy. If your child experiences any trouble, please call. We try to watch as close as we can, but we can't always see everything as we are driving and providing safe transportation for every child.

The Most Southern Place in the World-an NEH seminar

Over 300 applicants, 36 teachers selected, and one happy Mr. Mac. This summer Mr. Mac was selected to partici-



pate in an amazing and intense National Endowment for the Humanities (NEH) seminar which was taught at Delta State University in Cleveland, Mississippi. The week-long workshop encompassed the history, religion, food,

music, politics, economics, education, race relations, and living with Mississippi River in the Mississippi Delta.

A quick side note: NEH seminars are U.S. Government funded workshops and seminars that are meant to inculcate teachers with content material and pedagogical methods to use in the

classroom as quickly as the following school year. Teachers may apply for two seminars, but may only at-



tend one.

house

Before the seminar began, Mr. Mac read sixteen books and sundry articles that aided his understanding of the topics covered in lectures, documentaries, demonstrations, and field trips around the Mississippi Delta.

A salient topic in the seminar was the abduction and murder of Emmett Till, the fourteen-year-old Chicago native who violated Southern norms in 1955 while visiting his relatives in Money, Mississippi; his death touched off the modern Civil Rights movement in the United States. Mr. Mac was deeply humbled to meet Wheeler Parker, Emmett Till's older cousin, who travelled with Emmett from Chicago to Mississippi and witnessed Till's abduction by J. W. Milam and his half-brother Roy Bryant, at the Sumner Courthouse where Milam and Bryant were tried and acquitted for Till's murder.

In talking with Mr. Wheeler, a clear message of forgiveness (not forgetting) came across resoundingly to Mr. Mac and other seminar participants. A similar message of forgiveness was expressed by Charles McLaurin, a Student Nonviolent Coordinating Committee (SNCC) worker in Mississippi during the 1960s, who described the tumultuous and dangerous conditions of trying to register African Americans to vote. (Mr. Mac thanked him profusely for his service to his country.)

These are a few examples of the highly engaging events in which Mr. Mac participated, so you might be asking yourself, "How will he use this plethora material in the classroom?" Well, many, not all, topics will be incorporated into the classroom. From the reading series, Mr. Mac is working feverishly to produce Hyperdocs to help students better understand American history in which segregation permeated sports and music through the stories about Mahalia Jackson and LeRoy "Satchel" Paige. The topic of intersectionality will be discussed, and students will make this simple graphic organizer to understand how each person's background and experiences influences how that person interprets historical events or a passage of literature, for example. This exercise will be used to help students hone their inferential skills beginning with historical photographs then moving on to text passages. We'll see how it goes!

Early Intervention. Casandra Hohensee

What is Early Intervention?

Early Intervention is a free service that is offered by a variety of qualified providers to families who have a child from birth to age 3 with a developmental delay or health care need.

Who provides Early Intervention services?

District OR-1 has its own providers with specialties in speech and language, hard of hearing, occupational therapy, special education, and psychology. Along with our providers the district also consults with ESU 4 for a variety of other services, such as, audiology, physical therapy, and vision specialists.

Does my child qualify for services?

If you have a concern for your child's development or if your child has a health condition that will affect his/her development your child may qualify for services. After receiving parent permission, professionals and parents will work together to evaluate the child. The conclusion of the evaluation will determine if your child qualifies for early intervention under Nebraska's guidelines.

What are some indicators of developmental delay in early childhood?

Every child is unique and develops at their own rate. There is no direct indicator of delay, but looking at the developmental milestones of most other children it forms a guideline for comparison. A delay in any of the areas below could be a sign that you may need to have a child evaluated. This is not a complete list of developmental milestones but more information can be found by downloading the Staying on Track Mobile App.

Developmental Milestones

By Age 1:

- *Has tripled birth weight and doubled in length.
- *Enjoys opening and closing cabinet doors.
- *Crawls well.
- *Stands alone holding onto furniture for support.
- *Says "da-da" and "ma-ma" or equivalent.
- *Dances or bounces to music.
- *Interested in picture books.
- *Pays attention to conversations.

- *Claps hands, waves goodbye, if prompted.
- *Imitates adult actions such as drinking from a cup, or talking on the phone.
- *Offers toys or objects to others but wants them to be returned.
- *Pushes away toys, food and other items when she/he does not want them.
- *Points to desired objects.
- *Picks up finger foods.
- *Holds own bottle and drinks from it.

By Age 2:

- *Walks well.
- *Walks up steps with help.
- *Likes to run, but maybe wobbly when stopping or turning.
- *Can stack two to four blocks.
- *Feeds himself with a spoon.
- *Tosses or rolls a large ball.
- *Says "No".
- *Begins to show signs of independence and tries to do many things independently.
- *Enjoys exploring and gets into everything.
- *Gets angry sometimes and has temper

- *Has a rapidly growing vocabulary including names of toys.
- *Uses the words "me" and "mine."
- *Uses two to three sentences.
- *Echoes single words that are spoken by someone else.
- *Talks to himself and jabbers expressively.
- *Enjoys singing familiar songs and listens to short rhymes or finger plays.
- *Likes simple pretend play such as wearing hats and talking on the phone.
- *Distinguishes between finger and spoon foods.
- *Holds cup in one hand.

By Age 3:

Puts on shoes but cannot tie laces.

Tries to catch a large ball.

Can throw the ball overheard and kick a ball forward.

Climbs up and down a small slide by him/herself.

Can feed self with spoon and fork.

Avoids simple hazards.

Begins playing with a group of children participating in similar activities.

Names or points to self in photos.

Joins in nursery rhymes and songs.

Shows sympathy, modesty and shame.

Talks so that 75 to 80% of his speech is understandable.

Uses 3- to 5-word sentences.

Uses plural and increases use of verbs.

Vocabulary of 900 to 1000 words.

Uses verbal commands.

Uses plural and increases use of verbs.

Verbalizes toilet needs.

Asks "What's That?"

Uses adult pattern of chewing, which involves rotary action of jaw.

Make a referral to Nebraska's early intervention system by calling today at 402-471-2471 or toll-free 1-888-806-6287 to talk to someone about your concerns. A referral can be made by anyone who has direct knowledge about the child, however, only a parent or legal guardian can approve services moving forward

Insufficient Funds

PHYSICAL EXAMINATIONS AND IMMUNIZATIONS REQUIRED:

Nebraska State law requires that all students entering kindergarten, grade seven and all new students from out-of-state show evidence of having received a physical examination by a qualified physician within six months prior to enrollment. Evidence of this examination must be presented within 30 days of beginning enrollment unless the parent/guardian declares in writing his/her objection to the physical examination. The cost of the examination shall be borne by the parent. All students in grades 7-12 who are out for any kind of sport must show evidence of a physical examination before they may participate in the sport. Physical examination forms are available at the office or online at www.districtorl.org.

Gym reservations for the 2018-19 school year at Bennet and Palmyra will be available starting August 6th. To re-serve a spot at the Bennet Gym you will need to contact Linde Walter at Walter.lin@districtor1.net or Aaron Hoeft for the Palmyra Gym at hoeft.aar@districtor1.net with your contact info, activity, preferred practice dates, time, grade level and expected number of kids. Groups will need to pick one location as doubling up at both gyms will not be accepted due to the large number of requests and availability. Requests will be taken starting August 6th and no earlier by email only to the above individuals on a first come first serve basis.

ACTIVITY PASSES:

Activity pass are available for students and families. These passes will get you entrance into all PHS activities except Main Stage Play and Musical. Activity pass prices are:

\$125 for a family pass

\$50 for an adult pass

\$30 for student passes

\$5.00 Senior Citizen Pass for those 62 years and older

Students 7-12 are required to pay the \$30 activity fee to participate in activities at PHS.

(The family pass does not cover this fee)

IMMUNIZATION INFORMATION for 2018-19 is included in this mailing.

Students must show proof of immunization upon enrollment in District OR 1 Public Schools. Any student who does not comply with the immunization requirements will not be permitted to continue in school. Students with medical conditions or sincerely held religious beliefs which do not allow immunizations may complete a waiver statement which is available in school health offices. Students with a signed waiver statement may be excluded from school in the event of a disease outbreak.

ALLERGIES:

Due to a variety of student allergies, any treats brought into the elementary classroom need to be store bought with the ingredients clearly labeled. Thank you for your cooperation with this safety/wellness procedure.

Meal Charge Policy

It is the policy of the District to comply with the National School Lunch Program and School Breakfast Program and all other federal grant programs that provide free or reduced meals to qualifying students.

Student Eligibility

Families of students who may be eligible for free or reduced price school meals should submit an application to determine their eligibility. Applications are available through the Superintendent or Superintendent's designee. As long as an application is submitted on or after July 1, the application will be considered current for the new school year. A student may become eligible for free or reduced meals at any time during the school year if the household experiences a change in financial circumstances.

Meal Account Balances

The District will ensure that families can check their meal account balances in a manner other than exclusively online. The District will ensure that at least one form of meal account payment is free of charge.

The District encourages families to pre-pay without charge for free or reduced price meals. Notwithstanding the option to pre-pay, students and families will have a method to add funds during the school day. Any balance remaining in a pre-paid account shall carry over into the next month. Households approved for free or reduced price meals with funds remaining in their meal account at the end of the school year shall receive a refund. When a student leaves the District or graduates, the District shall attempt to contact the student's household to return any funds remaining in the student's meal account.

Unpaid meal charges may be carried over at the end of the school year as a delinquent debt and the District shall undertake reasonable collection efforts to collect unpaid meal charges classified as delinquent debt, pursuant to and in compliance with state and federal law. The District shall maintain records of its collection efforts and, once delinquent meal charges are converted to bad debt, its documentation establishing and handling of the bad debt.

SCHOOL LUNCH/BREAKFAST:

Our lunch accounting system is set up so that each family has a single-family account. Parents are expected to send money to be deposited in this account similar to a bank account. Their child/children in both the elementary school and the Jr.-Sr. High School will be able to spend that money for lunches or ala carte items. Expenditures will be deducted from the balance of the family account. The accounting system records when kids eat and how much was spent. When the account gets low the school will notify parents so that they can maintain a balance in their family account. Should the family account be exhausted, students will be expected to pay for their lunches prior to consumption.

Lunch & Breakfast Information

A carton of milk will be \$.35 for K-3 recess milk or for milk to accompany a sack lunch.

Breakfast prices will cost \$1.90 for students in grades K-6.

Breakfast prices will cost \$2.15 for students in grades 7-12.

Lunch prices will be \$2.55 for students in grades K-6.

Lunch prices will be \$2.65 for students in grades 7-12.

Lunch prices will be \$3.70 for visitors.

It will be very important to talk about the menu with your child each day so they are prepared with the decisions they have to make when going through the serving line.

Recess Milk Prices and Payments

The cost of recess milk will be \$.35 this year. Again this year we will include the cost of recess milk in with your family lunch bill. Each day your child has milk after recess, we will charge it to your family lunch account. You will no longer have to pay for recess milk separately. It is very important that you notify the school if you do not want your child to have recess milk, otherwise they will receive milk.

The Breakfast Schedule

The Breakfast program will start on Tuesday, August 14th. **No breakfast will be served on the first day of school**. If you have any questions about the school breakfast program please feel free to contact either school at the numbers listed above.

In order to serve more students in an efficient manner, we are going to have students from elementary and high school eating in both buildings. Breakfast will start at 7:30 a.m. at Palmyra High School and 7:45 a.m. at Bennet. Please note that District OR 1 school buildings open at 7:30 a.m. for HS students and 7:50 for Elementary Students not in the Rec. Program. Please do not arrive prior to that time.

Bennet country bus students and junior high and high school students will be able to start eating breakfast at 7:30 a.m. in Bennet. High school and junior high students will be served first, so they may eat and get on the bus. Elementary students from the Bennet country buses will be served after the high school students.

Palmyra town students and country students may start eating breakfast in Palmyra at 7:30 a.m. Palmyra town students must eat in Palmyra and be finished in time for the shuttle bus to Bennet at 8:05 a.m.

Elementary students from Douglas and Palmyra country bus students will eat at Bennet when they get off of the shuttle at 8:25a.m.

THE LUNCH SCHEDULE

Students will be told what time they go to lunch on the first day of school. Both the Bennet Elementary and Palmyra Jr/Sr High School campuses are closed, students may not leave for lunch.

STUDENT RECORD POLICY

District OR-1 Public Schools is required by Federal law to notify parents of students, and eligible students (a student who has attained eighteen years of age), that the school does maintain personally identifiable data on students enrolled in District OR-1 Public Schools. KIDS CONNECTION PROGRAM:

Kids Connection is a health insurance program developed by the State of Nebraska as an extension of Medicaid. Its purpose is to provide coverage to uninsured children across the state.

Kids Connection provides well care for your child in helping to prevent diseases, finding and treating problems early, and maintaining good health and development.

Regular check-ups include:

CARE baby check-ups and baby immunizations

yearly check-ups for school-age children, including school/sports physicals immunizations for school-age children dental check-ups and dental sealants vision and hearing tests.

Kids Connection also provides medical care for injuries and illnesses as early as possible. This is essential in treating or correcting health problems. Treatment includes doctor's visits, lab tests/x-rays, counseling, medications, dental treatment, hospital care, eyeglasses, and specialty service for children with disabilities or chronic health conditions.

Your child's eligibility to have health coverage through Kids Connection is based on your family's income and citizenship. Children can be eligible:

if they are under age 19.

if they were born in the United States or are legally admitted aliens.

even if both parents live at home.

even if one or both parents work full-time.

even if their family already has some type of health insurance.

Applications for Kids Connection are located in the school office. Please call the school if you have any questions regarding Kids Connection.

BEFORE AND AFTER SCHOOL RECREATION PROGRAM:

Bennet Elementary will continue to offer a before and after school recreation program. Starting on Monday, August 13th, for a fee, school age children attending Bennet Elementary may take part in this program. There will be a table at Open House on Thursday, August 9th for you to register your child. If your child will be attending the before or after school care program, please stop by to register your child.

Times: 7:00-8:20 a.m. and 3:30-5:30 p.m. We will also offer drop in service for

those students that are pre-registered. Students not pre-registered will not be allowed to take part in

the program.

Cost: \$2.80/hr per child. Time kept to the nearest 15 min. increment. A

minimum of one hour's time will be charged for after school

participation.

Payment: Prepayment in blocks of \$25.00 or more. There will also be a

\$25 non-refundable registration fee at the beginning of the year.

Supervision: Students will be supervised by at least one adult. Additional help will

be hired if needed so student to supervisor ratio doesn't exceed 15 to 1.


Structure: Activities will be offered such as board games, gym games, computer

Dear Parent/Guardian:

Children need healthy meals to learn. District OR 1 offers healthy meals every school day. Bennet Elementary breakfast costs \$1.90; lunch costs \$2.55. Palmyra High School breakfast costs \$2.15; lunch costs \$2.65. Your children may qualify for free or reduced price meals. Reduced price is \$.30 for breakfast and \$40 for lunch. If your child(ren) qualified for free or reduced price meals at the end of last school year, you must submit a new application by September, 28, 2018 in order to avoid an interruption in meal benefits.

This packet includes an application for free or reduced price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

- 1. WHO CAN GET FREE OR REDUCED PRICE MEALS?
 - All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR) are eligible for free meals.
 - Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
 - Children participating in their school's Head Start program are eligible for free meals.
 - Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
 - Children may receive free or reduced price meals if your household's income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced price meals if your household income falls at or below the limits on this chart.
- 2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY? Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and haven't been told your children will get free meals, please call or e-mail Robert Hanger, PO Box 130, Palmyra, NE 68418 or 402-780-5327.
- 3. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Use one Free and Reduced Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: Lisa Phillips, PO Box 130, Palmyra, NE 68418 or 402-780-5327.
- 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE ALREADY APPROVED FOR FREE MEALS? No, but please read the letter you got carefully and follow the instructions. If any children in your household were missing from your eligibility notification, contact: Lisa Phillips, PO Box 130, Palmyra, NE 68418 or 402-780-532 immediately.
- 5. CAN I APPLY ONLINE? You are encouraged to complete an online application instead of a paper application if your school district makes this option available. The online application has the same requirements and will

ask you for the same information as the paper application. Visit www.districtor1.org to begin or to learn more about the online application process. Contact Lisa Phillips, PO Box 130, Palmyra, NE 68418 or 402-780-5327 if you have any questions about the online application.

- MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT A NEW ONE? Yes. Your child's application is only good for that school year and for the first few days of this school year. You must send in a new application unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price for meals.
- 7. I GET WIC. CAN MY CHILDREN GET FREE MEALS? Children in households participating in WIC may be eligible for free or reduced price meals. Please send in an application.
- 8. WILL THE INFORMATION I GIVE BE CHECKED? Yes. We may also ask you to send written proof of the household income you report.
- 9. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced price meals if the household income drops below the income limit.
- 10. WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to: Robert Hanger, PO Box 130, Palmyra, NE 68418 or 402-780-5327
- 11. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes, You, your children, or other household members do not have to be U.S. citizens to apply for free or reduced price meals.
- 12. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you normally receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 13. WHAT IF SOME HOUSEHOLD MEMBERS HAVE NO INCOME TO REPORT? Household members may not receive some types of income we ask you to report on the application, or may not receive income at all. Whenever this happens, please write a 0 in the field. However, if any income fields are left empty or blank, those will also be counted as zeroes. Please be careful when leaving income fields blank, as we will assume you meant to do so.
- 14. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
- 15. WHAT IF THERE ISN'T ENOUGH SPACE ON THE APPLICATION FOR MY FAMILY? List any additional household members on a separate piece of paper, and attach it to your application. Contact Lisa Phillips, PO Box 130, Palmyra, NE 68418 or 402-780-5327 to receive a second application.
- 16. MY FAMILY NEEDS MORE HELP. ARE THERE OTHER PROGRAMS WE MIGHT APPLY FOR? To find out how to apply for SNAP or other assistance benefits, please go online to ACCESSNebraska.ne.gov or call 1-800-383-4278.
